Skyline Corral Reservation Application

- Members will be supplied a portable sign to be left at the gate so there is no intrusion to your event.
- Members are responsible for any damages to Skyline Corral caused by the event and their guests.
- Primary SRPOA member must be present during the full duration of the event.
- Reservations are on a first come, first serve basis.
- Officers of SRPOA have the right to refuse the use of its facility for an event that is not in the best interest of the property or the association.
- Payment: Two checks, (one for the fee and one for the deposit) each (payable to SRPOA) with your reservation
 application is required to reserve the area. One of the two checks will be returned when the portable reservation
 sign has been returned.

Skyline Corral User Fee's

Effective, July 15, 2020

Members in good standing do not need to make a reservation to use the facility. Reservations only need to be made if you would like to use it exclusively therefore closing it off to other members. Reservations will close the Brush Pile during the event.

The fees SRPOA has charged for the private use of Skyline Corral have changed due to an ongoing increase in maintenance, insurance, taxes and utilities. The biggest change comes from the use of the grounds for weddings and receptions for the afore mentioned reasons. The cost to reserve Skyline Corral for weddings (for members in good standing only, including their dependents) is now \$500. Sponsors must be present during the entire event. A deposit of \$100 and a completed reservation form is required to reserve the property. The \$100 will be refunded when the reservation sign is returned after the event and the property (Lot 86) is returned to its original condition before the event. All trash, decorations and any other paraphernalia brought in for the event must be removed. If additional cleaning is required by a SRPOA member or a hired cleaner/repair company, or damage was incurred and not repaired, the deposit will not be returned and an additional clean-up and repair fee of \$400 will be assessed (total damage assessment of \$500)

All other activities such as family reunions, graduation parties, birthdays, horse and other arena related events, etc. shall increase to \$50 for members in good standing. Sponsors must be present during the entire event. Ain addition to the rental fee, a deposit of \$50 is required at the time of booking, and refunded if the property is returned in the condition it was found. All trash, decorations and any other paraphernalia brought in for the event must be removed. If additional cleaning is required by a SRPOA member or a hired cleaner/repair company, or damage was incurred and not repaired, the deposit will not be returned and an additional repair fee may be assessed, not to exceed the cost of the repair.

Non-Members wishing to use the amenities of Skyline Corral for the purposes of family and graduation pictures may do so by obtaining written permission from a SRPOA board member ONLY. Requests can be made by email at: www.skylineranches.org. Your Board of Directors is reaffirming the rule that Skyline Corral and any other property (trails & other common ground) belonging or controlled & maintained by SRPOA is 'Private', and for use by Members in Good Standing only. SRPOA members and its Board of Directors neither assume nor convey any liability for damages to persons or property related to events taking place on common property owned by SRPOA. All activity on the grounds is at the person's own risk and liability.
